


Paterson First Nations Youth Apprenticeship Program

The generosity of Andrew Paterson and Family continues as First Nations youth in the Lake of the Woods Region are gaining valuable first time job skills.

The Paterson Family established a \$500,000 endowment fund with the Kenora and Lake of the Woods Regional Community Foundation in 2006. Proceeds from the endowment help to place students with local professional workplaces for the summer months, where they gain a meaningful start to their working careers.

A total of fourteen students have benefitted from the program thus far and many continue to pursue post-secondary training in the fields of health and wellness and nursing.

"Everyone needs that first big break. This is what I am providing with this program. I am very pleased that many of the girls have continued on in furthering their education in the health field" says Mr. Paterson.



Youth in Philanthropy (YIP)

YIP is a program of the Kenora and Lake of the Woods Regional Community Foundation. It is a growing movement that engages young people in building philanthropy in communities across Canada. Since the fall of 2006 the program has been running at Beaver Brae Secondary School and St. Thomas Aquinas High School. The sponsors this year are Kenora Rotary Club and Copperfin Credit Union.

In 2010 YIP students, from each high school, handed out four \$700 grants to local charities for a total of \$5,600 Beaver Brae selected as their recipients; Women's Shelter Saakaate House, The Cat Shelter, Triple PLAY, and the Kenora Fellowship Centre. St. Thomas Aquinas students presented grants to the Lake of the Woods Railroaders' Museum, the Kenora Sexual Assault Centre, Iggy's Wildlife and Rehabilitation Centre, and Breakfast for Learning at Pope John Paul II School.

Choosing Where to Give

The Community Foundation approach to giving is unique in the way bring donors to the table as community builders, and help them formulate their philanthropic goals, matching their interest and concerns with community needs and organizations, and finding innovative and responsible ways to give their investments a lasting impact. Donors may contribute to any of one of our current funds listed below or may wish to establish a fund of their own.

Community Fund

Is not tied to a specific charity or area of interest. This allows the Community Foundation to respond to the immediate and changing needs of the community.

Field of Interest Fund

Allows the donor to designate a specific area of interest from which charitable grants can be made including the following categories: Arts and Culture, Health and Wellness, Social Welfare, the Environment or the general needs of the Community.

Special Interest Fund

Donors can contribute to any of the following funds with a gift of any size: Canadian Pacific and Kenora Employees Endowment Fund for Social Welfare, Paul and Patricia Reishel Animal Welfare Endowment Fund, Keewatin Forever Endowment Fund or Treaty Three Police Service Endowment Fund for the Kenora Fellowship Centre.

Designated Fund

Gives donors the opportunity to specify which charity they would like to support in perpetuity.

Donor Advised Fund

Enables donors to have ongoing participation in the selection of charities that will benefit from their gift.

Charitable Agency Endowment

Offers registered charities the opportunity to establish an endowment fund within the Community Foundation.

Memorial Fund

Can be established in the form of any of the above listed fund types, in memory of a family or individual. Grants from these funds are tailored to the donor's wishes.

Managed Fund

A charitable organization entrusts the Community Foundation with the management of their funds, while they retain ownership.

Charitable Agency Endowment Funds

Kenora Association for Community Living Fund

Contributions to this fund will help the association achieve its goal of ensuring that all people with special needs have the opportunity to live meaningful and satisfying lifestyles as equals in their community.

Public Library Fund

Will allow friends of the Kenora Public Library to make a meaningful contribution to its future.

Triple P.L.A.Y. Fund

Offers donors the opportunity to make a lasting gift to Triple P.L.A.Y., a program of the Lake of the Woods Child Development Centre. Triple P.L.A.Y. makes sports, recreation, arts and culture activities accessible to all children in the Kenora Region.

Pinecrest Home for the Aged Fund

Enables donors to make endowed contributions in support of the Kenora and District Home for the Aged (Pinecrest Home). The investment income from the fund will be used by Pinecrest to support their programs.

Kenora Special Olympics
