We are very pleased to present our 2013 Annual Report to the community. This year, we continued to support His Excellency David Johnston, Governor General of Canada and Patron of Community Foundations of Canada call to action to work to-

wards becoming a more Smart and Caring Nation. In partnership with the Winnipeg Foundation, we developed our first professional video highlighting our work in the region. We were thrilled to know that it received over 2,200 views in the first two days of posting. We established new partnerships with existing fundraising sponsors, who transitioned over to become our operating sponsors. We benefitted from a wonderful reception held at the Royal Lake of the Woods Yacht Club, by Bryce and Nicki Douglas. Our volunteers, donors and grant recipients helped introduce us to a whole new audience. The excellent work done by our Youth in Philanthropy groups continues to be appreciated and recognized by many in our community. We received significant gifts from FIREFLY, the Knights of Columbus and in celebration of the retirement of James Retson. We look forward to the distribution of grants from these funds.

Along the way in 2013, we continued to connect with new donors through the "Give Where You Live" marketing program, designed to encourage individuals, families and organizations to establish a named endowment fund for a \$2,500 contribution. Our endowment donations totaled \$284,000, while \$226,000 was distributed as grants. We also achieved a 18.46% rate of return and completed the year with \$3.5 million in assets.


























Choosing Where to Give

Community Fund

This fund is not tied to a specific charity or area of interest. This allows the Community Foundation to respond to the immediate and changing needs of the community.

Field of Interest Fund

Designated Fund
