

Since our 2004 inception, we have issued grants totaling \$3,700,000.

SCOPE

We are one of 191 Community Foundations across Canada. Ninety (90%) percent of Canadian communities have access to a community foundation. Collectively Community Foundations have combined assets of more than \$5.2 billion and have granted hundreds of millions of dollars back into communities over our 97-year history.

WHERE TO GIVE

Community Fund

This fund is not tied to a specific charity or area of interest. This allows the Community Foundation to respond to the immediate and changing needs of the community.

Field of Interest Fund

Allows the donor to designate a specific area of interest from which charitable grants can be made, including the following categories: Arts & Culture, Health & Wellness, Social Services, Animal Welfare, Community at Large, or the Environment.

Designated Fund

Gives donors the opportunity to specify which charity they would like to support in perpetuity.

Donor Advised Fund

Enables donors to have ongoing participation in the selection of charities that will benefit from their gift.

Charitable Agency Endowment Fund

Donors can contribute to any of the 10 Agency Endowment funds established by registered charities,

Memorial Fund

Can be established in the form of any of the abovelisted fund types, in memory of a family or individual. Grants from these funds are tailored to each donor's wishes.

Funds Held for Others

A registered charity entrusts the Community Foundation with a portion of their assets, while the charity retains the ownership of the assets.

DONORS

The Community Foundation thanks all of our donors for contributing to the future of the Kenora and Lake of the Woods Region. Proceeds from the Festival of Trees, Making Waves, and the Gillons Charity Golf Tournament are used to support our operating expenses. All other gifts, with a few limited exceptions, are placed in our permanent endowment funds. Donations are invested as capital and the investment growth is distributed to registered charities annually in line with the donor's wishes. The single most important work for any community foundation is the disburse grants to local charities to support their community efforts. In 2019 KLWCF gave out a total of \$ 493,519.52 to 54 grant recipients.

FUTURE LAUNCH COMMUNITY CHALLENGE





YOUTH REWARDED

In 2019 our Foundation was one of 150 mid-sized foundations across Canada that was awarded "youth leadership" grants from the Royal Bank of Canada. Thanks to the RBC Future Launch Community Challenge.

We asked, "What is your boldest idea to an urgent local need?". Two of our youth-led responses were awarded \$30,000 total.

The Kenora Youth Wellness Hub was awarded \$15,000 from the Royal Bank of Canada as part of their Future Youth Launch. Their Youth Advisory Council will co-create a diverse set of drop-in programs to support youth in all dimensions of wellness, emphasizing the unique needs, interests, and realities of young people in the Kenora district.

Wabauskang First Nation used their \$15,000 to provide kids from K-12 with healthy food at school to support their learning. The youth will also learn nutrition and cooking skills by being their own chefs for the lunch menu items.

APPLYING FOR A GRANT

The Community Foundation considers grant applications made by charitable organizations that fall into the following categories: Arts and Culture, Health and Wellness, Social Welfare, Animal Welfare, the Environment and the Community at large.

Only registered charities in good standing with CRA, offering programs benefiting residents and visitors to the Kenora and Lake of the Woods Region, are eligible to apply. Organizations are eligible to apply for funding once per calendar year. If you are a not-for profit, but not a registered charity, you must complete the Non-Profit Organizations form from our website, and attach it with your application.


